

# GENERAL TERMS AND CONDITIONS

## « Business Meeting 2018 »

### **Art.1. Organization:**

The Power Business Meeting 2018 shall be organized by the Chamber of Commerce and Industry of Bourgogne- Franche-Comté (hereinafter the "Organizer") and shall be held in Belfort on June 13<sup>th</sup> and June 14<sup>th</sup> 2018 at the Atria Congress Centre.

In the likelihood of an event beyond its control or as a result of force majeure, the Organizer shall have the option of changing the dates or venue for this event, or cancel it altogether after having notified the participants.

### **Art.2. Obligations of the Organizer:**

The Organizer shall only be bound by an obligation of means.

### **Art.3. Registration:**

Registration for The Power Business Meeting 2018 shall only be deemed final upon acceptance of the registration by the Organizer.

### **Art.4. Cancellation and withdrawal:**

Registration shall be considered firm and final. There shall be no reimbursement whatsoever should order-givers fail to attend the event on the day.

### **Art.5. Registration Fees:**

Registration Fees of The Power Business Meeting 2018 are indicated in the document entitled "Registration Fees – Power Business Meeting 2018" available on the website [www.rdv-energie.com](http://www.rdv-energie.com) and the On-line suppliers's registration form.

### **Art.6. Payment:**

Suppliers shall be asked to settle payment upon registration, which shall serve to confirm their registration. The Organizer shall then institute the relative procedure and provide for full or partial services subject to deadlines as of this date.

### **Art.7. Insurance:**

All participants shall be asked to provide justification of insurance covering civil liability as well as any damage for which they might be held responsible: notably: theft, fire, deterioration, destruction of any materials or installations. The Organizer and its insurers shall waive their right to recourse against exhibitors and their insurers. Reciprocally, the exhibitors and insurers shall waive their right to any recourse against the Organizer and its insurers.

### **Art.8. Stand:**

Exhibitors shall not be permitted to exhibit any materials outside or above the area of the stand attributed to them. Participants shall undertake to be present at their stand for the entire duration of the event.

### **Art.9. Advertising:**

After registration has been accepted, the Organizer shall grant participants the right to include the following mention on their commercial and advertising documents: "Power Business Meeting 2018 participant, June 13<sup>th</sup> and June 14<sup>th</sup> 2018 - Belfort France – Atria Congress Centre"

On the same token, participants shall authorize the Organizer to mention their participation in the said event.

After registration has been accepted by the Organizer, participants shall authorize the Organizer to relay their contact details.

### **Art.10. Confidentiality:**

In accordance with the legislation in force at the date of final registration, all persons having provided personal details shall have the right to access and modify the information concerning them.

### **Art.11. Model release:**

By registering for the event, Power Business Meeting 2018 participants shall authorize the Organizer to make use of their image within the strict framework of organizing and promoting events organized by the Bourgogne Franche-Comté and Alsace Chamber of Commerce and Industry.

### **Art 12. Email management:**

By registering for the event, Power Business Meeting 2018 participants shall authorize the Organizer to use their email addresses for the sending of information regarding The Power Business Meeting 2018 and for the promotion of other events organized by the Bourgogne Franche-Comté and Alsace Chamber of Commerce and Industry.

Contact details may also be provided to partners.

This data shall allow for participants to be kept informed of upcoming events and to receive information by email. To follow-up on their participation. To customize communications notably via the sending of newsletters, special offers and special emails in the context of communications about the event.

### **Art.13.Evaluation**

Power Business Meeting 2018 participants will have to answer to several feedback forms (6 and 13 months after the event).

### **Art.14. Choice of forum clause:**

Disputes which may not be settled out of court, shall be brought before the Commercial Court of Besançon (France), who shall have sole jurisdiction
